*Some 10 th and all 11 th & 12 th grade students will participate in Grand Canyon University's dual enrollment program, allowing them to earn college credit. Additional tuition fees will apply per GCU course taken, according to GCU's dual enrollment rates, which are approximately \$320 per course (includes book fees), with students expected to take approximately four courses per year.

The enrollment commitment is charged for each student every year and is due at the time your enrollment contract is submitted. The commitment is non-refundable and non-transferable. If the current student commitment is not paid by 02/15/2026, the student's spot will be released to new applicants, and the student will be considered a new applicant subject to new student fees and processes.

Multiple Student Discount

Families with multiple students enrolled are eligible for a discount. Each additional student, after the first student, will receive a \$300 discount. This discount will apply to the youngest student(s).

Volunteer Discount

Families who commit to volunteering 30 hours or more during the 2026-2027 school year, in a role that directly serves the school's needs and is pre-approved for discount eligibility, qualify for a \$500 discount on the family's total base annual tuition. The 30 hour commitment must be agreed upon and an SHC Volunteer Agreement signed before **October 1st, 2026** for discount eligibility.

If the 30-hour commitment is not completed by the end of the school year, or if the agreed-upon duties are not fulfilled, the \$500 discount will be reversed. The discount amount will then be added to your payment account in May or at the time of non-fulfillment, whichever comes first.

Tuition Assistance

At Spring Hills Christian, we value partnering with parents in disciplining their children. To support this mission, we strive to keep tuition affordable, but we recognize that some families may need additional assistance.

Spring Hills Christian offers a limited amount of Tuition Assistance for families in need of financial aid. We utilize FACTS to assess financial need fairly and objectively. Recommendations from FACTS are used to determine Tuition Assistance amounts.

Determination of Tuition Assistance is based on:

1. Availability of Tuition Assistance funds.
2. Family need based on the assessment and recommendation by FACTS.
3. Submission of the application and all supporting documents to FACTS by **April 1, 2026**.

Additional Information:

- Applications submitted after the deadline will be considered only if funds remain available.
- Tuition Assistance eligibility is reevaluated annually, and **a new application is required each year**.
- Families currently enrolled in SHC must have a record of on-time payments to qualify for Tuition Assistance. To remain eligible for Tuition Assistance, all families must continue to maintain on-time payment records.
- The maximum Tuition Assistance any family may receive will not exceed 30% of the Base Annual Tuition.
- Enrollment Fees and other fees are not eligible for Tuition Assistance.

Families can apply for Tuition Assistance by logging into their FACTS Family Portal. Once logged in, select “Financial” then select “Apply for Grant & Aid”. The application fee is \$40.

In addition to SHC Tuition Assistance, our students are eligible for **The BASIC Fund**, which is available based on income, to families entering private education for the first time. The Basic Fund is awarded on a first-come, first-served basis. This is an outside program and not conducted by SHC. Go to basicfund.org for more information.

Late and Returned Payments

Payment plans are set up for each family during the enrollment process through FACTS. Payments not successfully processed by the 10th of each month will incur a \$25 late fee for the first two months of late payments. After the second month of late payments, the late payment fee will increase to \$50 the third month, \$75 the fourth month, \$100 the fifth month, etc. Families with recurrent, excessive late payments will be at-risk of losing their enrollment.

If an account is over 60 days delinquent, a notice will be issued requiring full payment within 10 days. If payment is not received by that time, parents will be asked to withdraw their child from the school until all outstanding balances are cleared, unless special arrangements have been made with the school administration.

If a payment is returned by the bank there will be a \$30 charge.

Late Pickup Fee

A late fee of \$25 per 15 minutes will be added for pick-ups after 3:00pm.
